Per Anacortes Municipal Code Chapter 6: All hobby kennel licenses shall be good for one year, and the annual license fee shall become due and payable on January 1st of each year. The operator must keep a copy of the license at the hobby kennel location at all times and said license is non-transferable. Prior to the issuance of the hobby kennel license, or any renewal thereof, the animal control officer shall inspect the applicant’s premises. If it passes inspection and the applicant does not exceed the number of animals defined in section 6.02, the animal control authority shall issue the license. The license may be revoked if the hobby kennel is operating in violation of this title or the conditions set forth by city council or the animal control officer.
